## How To Register With Trust Wallet v1.12-29-23

For the sake of simplicity, these instructions were created using the Trust Wallet phone app, but MetaMask has a similar registration process. You must have at least 0.13 BNB (which includes BNB gas fees) before starting the steps below. Both Trust Wallet and MetaMask wallets allow you to purchase BNB coin with a Visa or Mastercard. The card processing fee is about 20%, so you must add this to the minimum amount you will need to register.

**STEP 1:** Download and/or open your Trust Wallet or MetaMask wallet app on your phone.

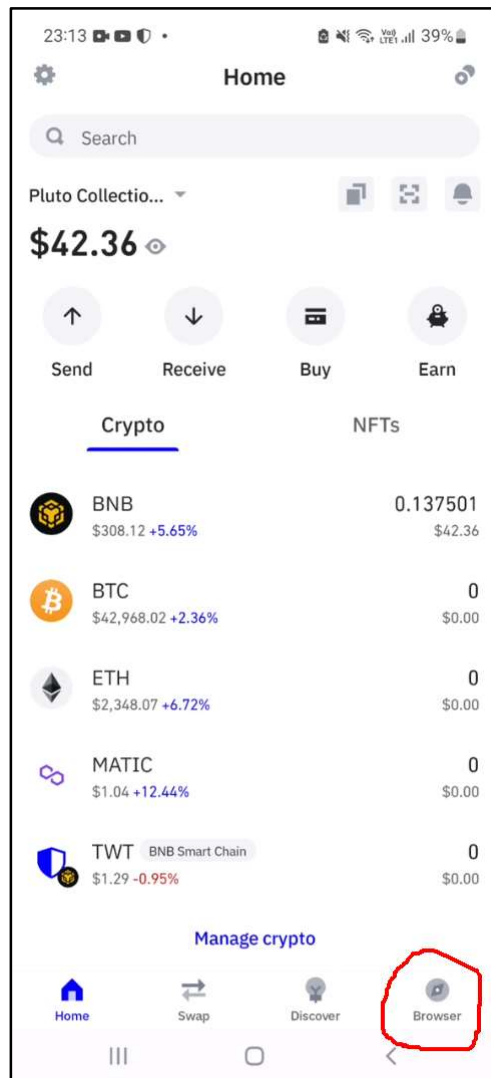

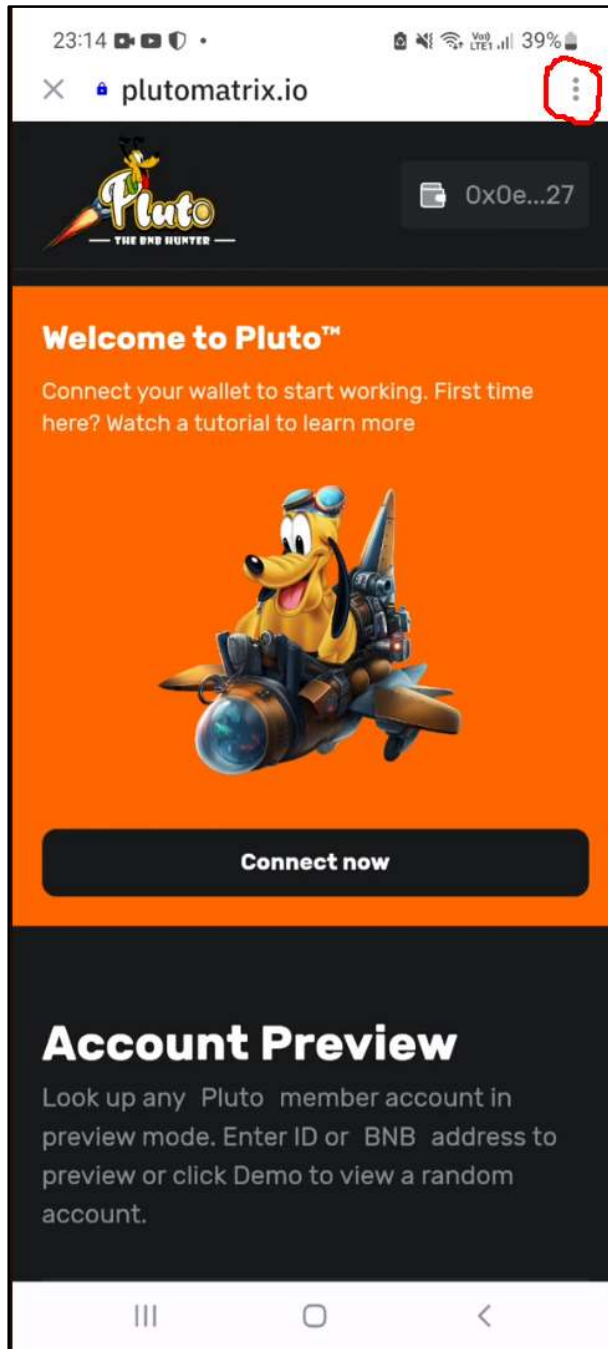

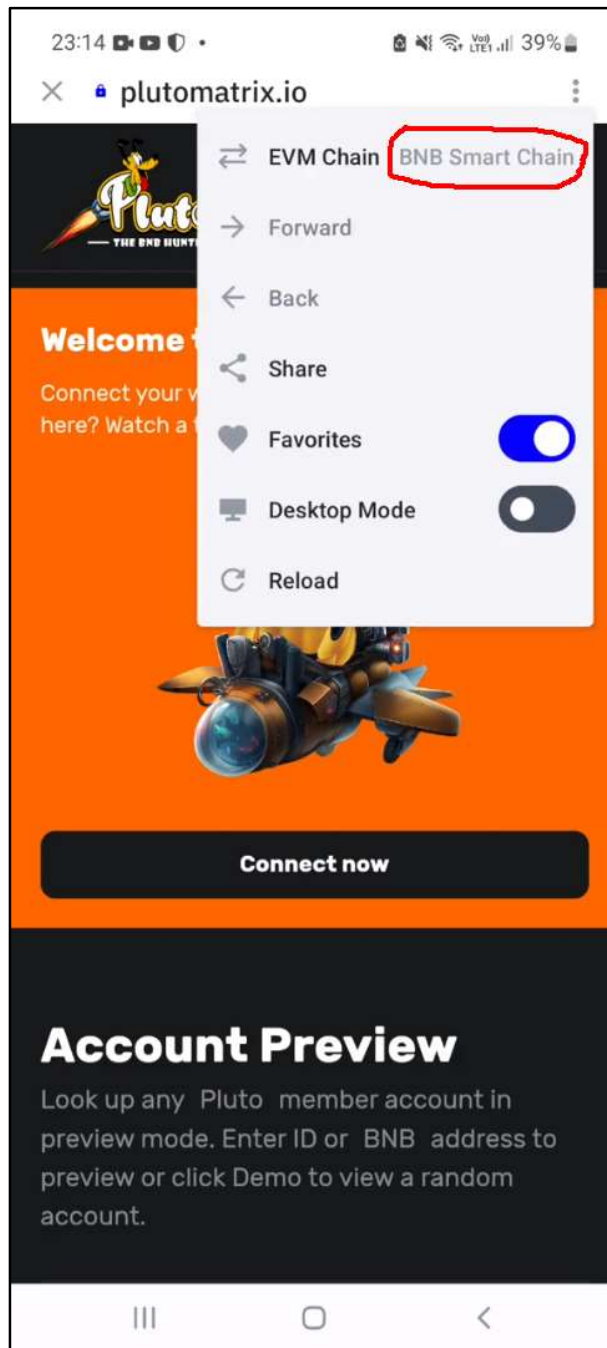
**STEP 2:** Click to open the Trust Wallet or MetaMask wallet browser within the app, then in the “Search” bar, type in the following link of your referrer: [https://plutomatrix.io/register/\(ReferrerID#\)](https://plutomatrix.io/register/(ReferrerID#)). (Note: If you need to buy BNB with a Visa or MasterCard, click the “Buy” button located to the right of the “Receive” button to view provider options.)



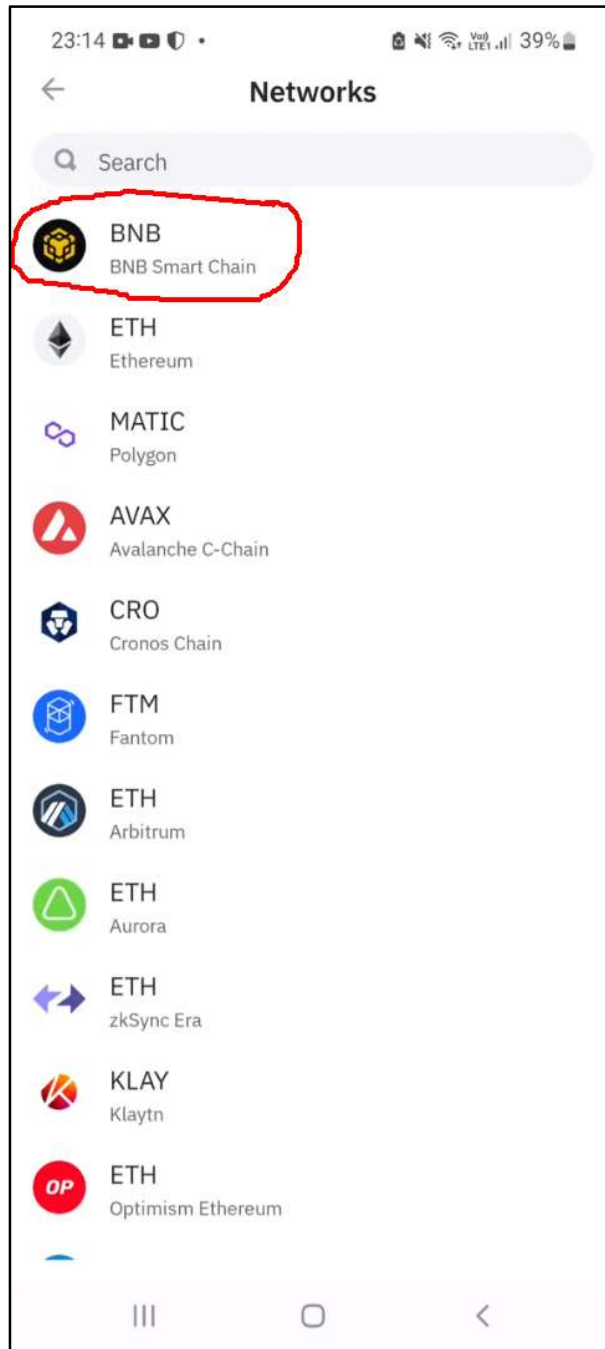
**STEP 3:** On the top right side (with Android) or bottom right side (with Apple IOS) of the Pluto Co-Matrix “Registration” page, click the three dots (also called the “meatballs” menu symbol).



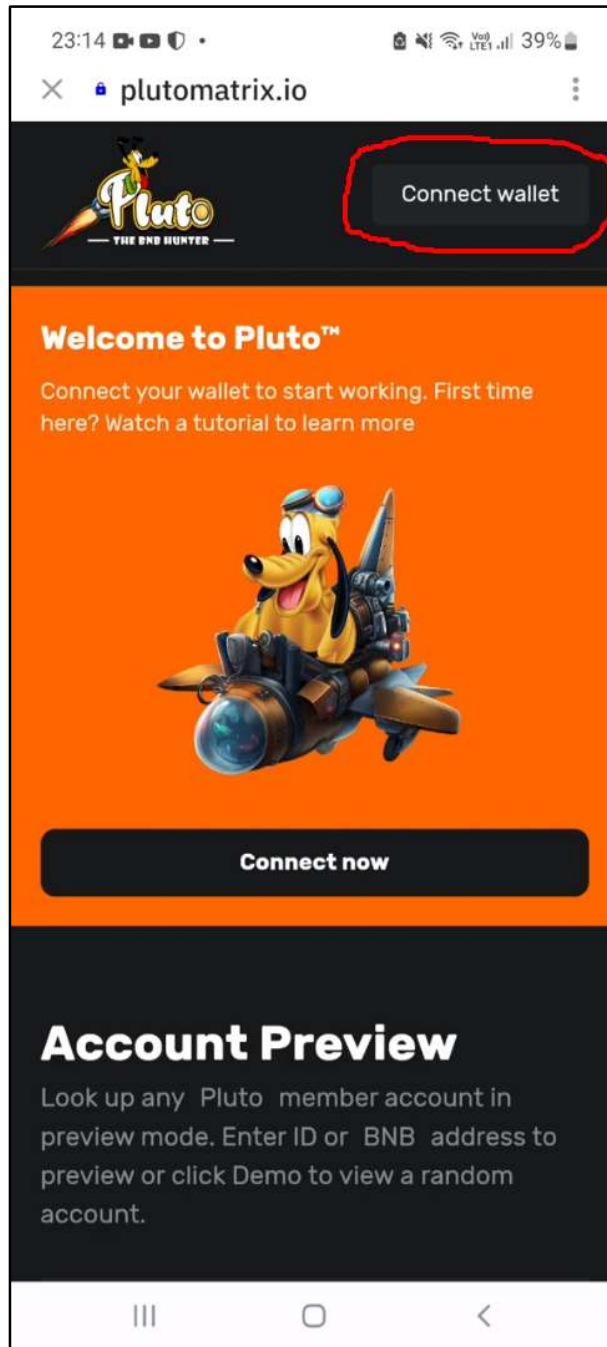
**STEP 4:** Next, change the EVM Chain (server) to “BNB Smart Chain”. If the EVM Chain is already set to “BNB Smart Chain” don’t change it. But most likely, it will be set to “ETH” by default. To change it, simply click the link that reads: “EVM Chain...”



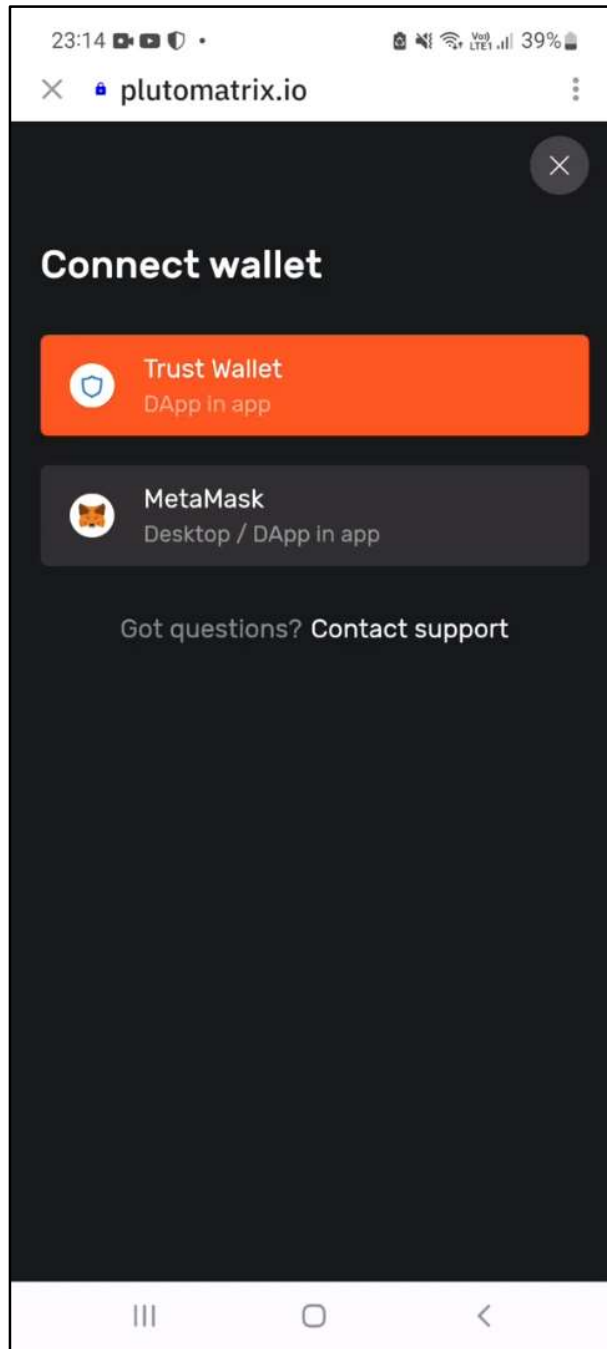
**STEP 5:** After clicking the “EVM Chain...” link, it will open up the “Networks” page. Click “BNB Smart Chain” (if it is not already selected as your default server, as shown in “Step 4”).



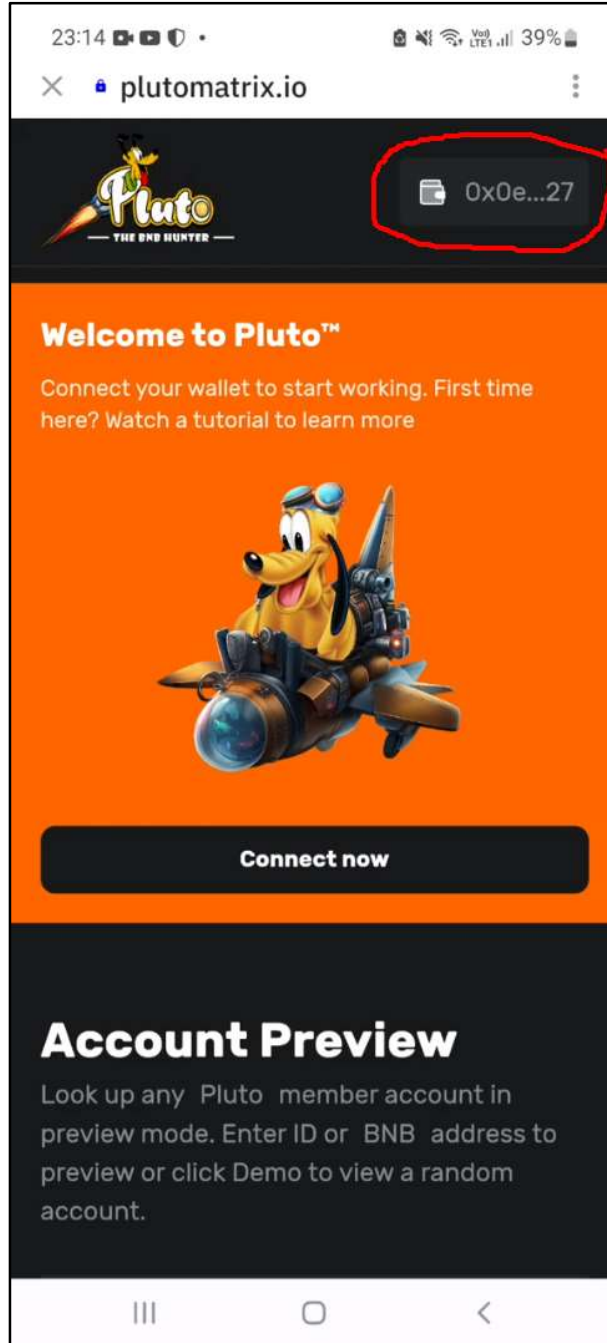
**STEP 6:** Now return back to the “Registration” page and click the “Connect Wallet” button located on the top right of the page.



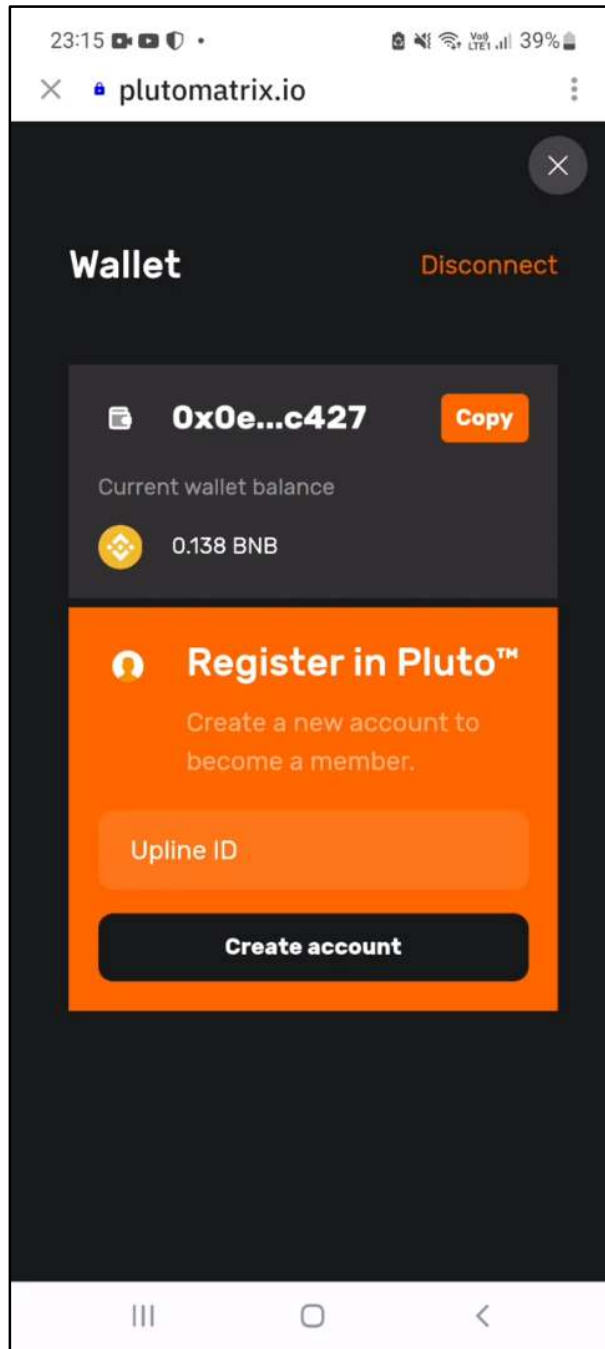
**STEP 7:** Next, select either “Trust Wallet” (if you’re using Trust Wallet) or “MetaMask” (if you’re using MetaMask). Your selection will turn an “orange” color. Then click the “X” button at top right of “Connect Wallet”.



**STEP 8:** Again, return to the registration page where you should see a portion of your wallet address on the top right of the page, starting with “0x...” and ending with the last “2” digits of your wallet. Click on your wallet address, and a “Register in Pluto” page will appear.

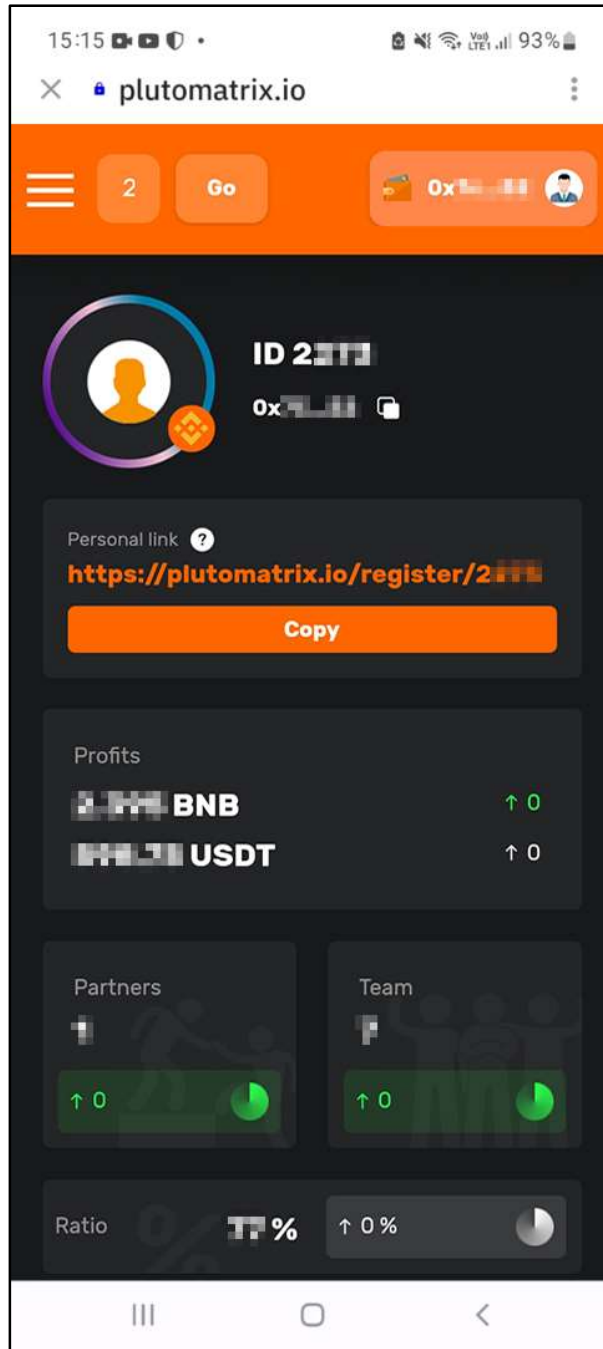


**STEP 9:** On the “Register in Pluto” page, you must enter the ID# of your Referrer in the “Upline ID” box, then click the “Create Account” button.

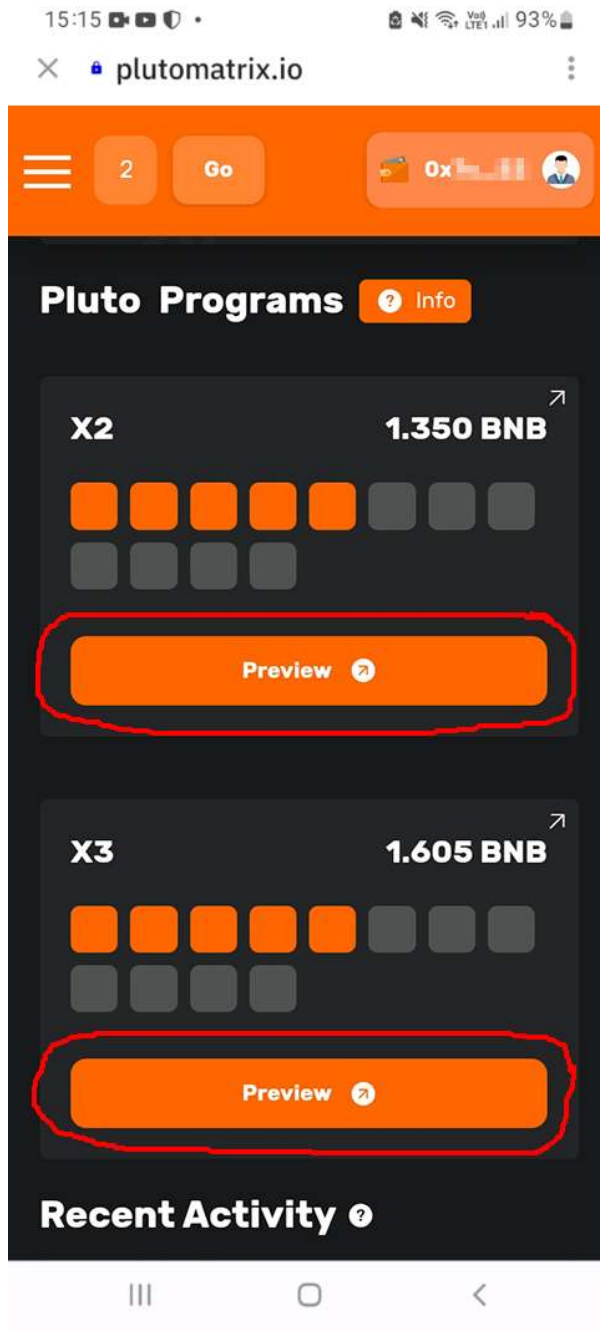




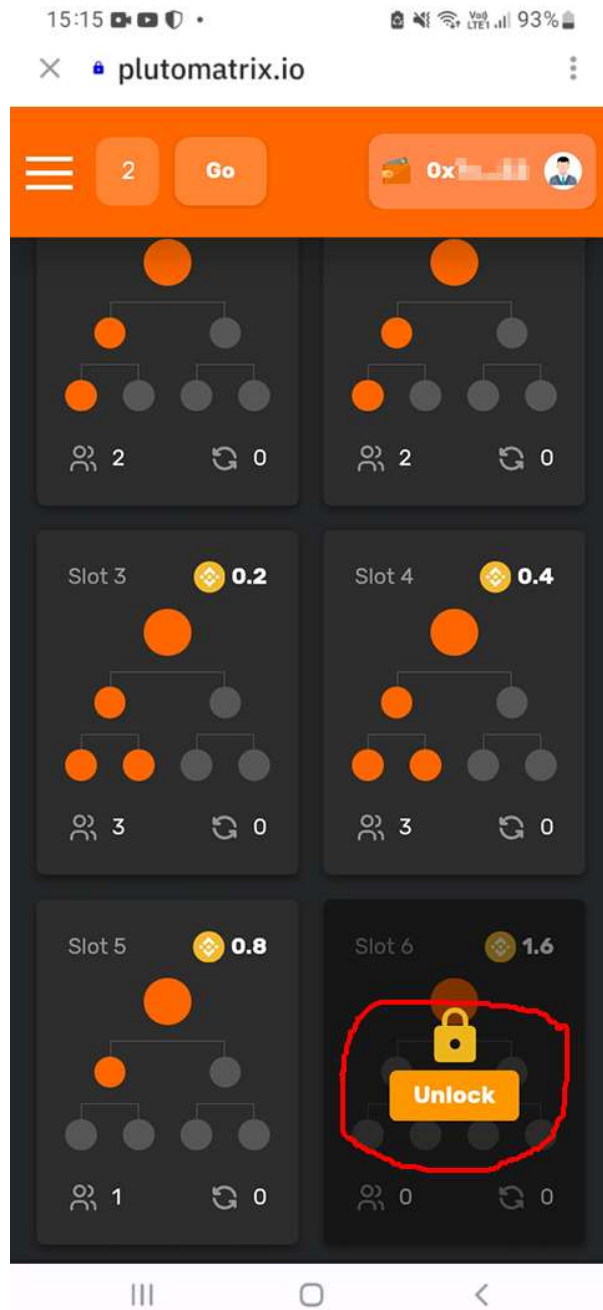
**STEP 10:** You will now be redirected to your "Dashboard" area page located at: <https://plutomatrix.io/dashboard>, where you can now start purchasing up to Slot 8 of the "X2" and/or "X3" Matrix Smart Contracts during pre-launch. After pre-launch, you will be able to purchase up to Slot 12 of each "X2" or "X3" Matrix Smart Contract. (Note: The Dashboard below shows results with just "1" referral, after just 24 hours! Results are NOT typical. Please see income disclaimer below.)



**STEP 11:** Simply scroll down to X2 or X3 area and click the (orange) “Preview” button, then scroll to the Matrix “Slot” you want to purchase. (Note: The Dashboard below shows “5” Slots of the X2 and X3 Matrices that have been purchased in “orange” squares.)



**STEP 12:** Lastly, click the “Unlock” button, which will immediately connect to your wallet. Next, click the “Approve” button to authorize the purchase. Simply continue this process for every “Slot” (1 to 8 during pre-launch) in the “X2” (2x2) and/or “X3” (2x3) Matrix Smart Contract(s) that you want to purchase. You can also click the “Next” button to purchase the next higher Slot. (Note: The Dashboard below shows “5” Slots of the X2 Matrices have already had paid users fall into them, represented by the “orange” circles.)



**That's it! You're done!** Your referral link and ID# (located at the end of your referral link) is located at the top of your “Dashboard” page. Referring is optional, but you will speed up your results by referring at least “2” people who will do the same. Remember that commissions are paid instantly into your wallet and will reflect on the BNB public blockchain located at: <https://bscscan.com>. Simply enter your BNB Smart Chain wallet address (starting with “0x”) into the “BNB Smart Chain Explorer” box. Then click “Internal Transactions” button to see real-time reporting. Because your Trust Wallet or MetaMask wallet is directly connected to the Pluto Co-Matrix Smart Contract, incoming transaction will not appear in the transaction history section of your wallet.

**How to calculate how much BNB you will need purchase with a credit card.** When you open your Trust Wallet or MetaMask wallet, you will see the current price of BNB. Say for example it's \$320 per BNB, and you know you will need at least 0.1 BNB to purchase Slot 1 of X2 and X3, plus 25% BNB gas fees (0.13 BNB), and 20% for credit card processing fees. It means you will need  $\$320 \times 0.13 = \$41.60 + 20\%$  (\$8.32) = \$49.92 minimum on your Visa or MC.
